



**Orlando Science Center  
Preschool Summer Camp  
Waiver and Release**

The Orlando Science Center Preschool is a Department of Children and Families (DCF) licensed child care center. Our Florida Administrative Code Child Care Standards (Chapter 65C-22) mandates our guidelines, standards and regulations to maintain the highest safety and security for the care of the children, families, staff and center we serve.

I hereby consent and approve of my child to participate in the Orlando Science Center Preschool 2021 Winter Break Camp program and expressly release and give permission to the Orlando Science Center, Orlando Science Center Preschool, and its agents and employees to.

The following required child care standards state:

Florida Administrative Code Section 65C.22.006(2) A current physical examination (Form 3040) and Immunization record (Form 680 or 681) within 30 days of enrollment.

Florida Administrative Code Section 402.3125(5) Parents receive a copy of the Child Care Facility Brochure, "KNOW YOUR CHILDCARE FACILITY".

Florida Administrative Code Section 65C-22.006(3)©2 Parents are notified in writing of the disciplinary practices used by the childcare facility. Orlando Science Center Preschool's discipline policy is located in the Preschool Handbook and posted in classrooms.

Florida Administrative Code Section 65C-22.006(3) Childcare facilities are not required to give medication. Orlando Science Center Preschool does not administer oral or topical medications. Children must be able to administer or take medication by themselves. Preschool staff cannot administer any type of medication. This policy is located in the Orlando Science Center Preschool Handbook.

I attest that the information provided in the enrollment form is complete and accurate.

I have read, understand, and agree to abide by the conditions outlined in the Medical Release and Health History:

- The Orlando Science Center, its agents and employees do not administer oral or topical medications, including epi -pens.



- **Children must be able to administer or take medication by themselves (excepting Epi-Pens and Rescue Inhalers).** Please send only those medications (including Epi-pen) that absolutely must be taken during the Camp hours (including early and late care sessions). Required medication must be placed in the original packaging, properly labeled with the child's name and dosage, and placed in a Ziploc baggie.

Title VI of the Civil Rights Act of 1964 prohibits discrimination based on race, color, or national origin including limited English proficiency, in programs or activities receiving Federal financial assistance.

I understand and agree that the Department of Children and Families (DCF), Early Learning Coalition of Orange County (ELCOC) or any other child care licensing/accreditation personnel may have access to my child's records.

I understand and agree that I will provide a copy of my child's current Immunization record and Health Certificate within 3 days of the start of my child's 2021 Winter Break Camp week.

I understand and agree that I received, read understand and agree to abide by the conditions outlined in the Know Your Child Care Facility Brochure given to me by the Orlando Science Center Preschool.

I understand and agree that I have received, read, understand and agree to abide by the conditions outlined in the Orlando Science Preschool Handbook.

I understand and agree that I have received, read, understand and agree to abide by the conditions outlined in the Influenza Virus Brochure.

I understand and agree that I have received, read, understand and agree to abide by the conditions outlined in the Distracted Adult Brochure.

I understand and agree that the Orlando Science Center assumes and has no responsibility for any injuries or illness, which my child may sustain as a result of his or her participation in the camp program.



I understand that the Orlando Science Center is not responsible for personal property lost or stolen while a program participant on OSC premises.

Orlando Science Center will cooperate fully with local, state, or federal officials in any investigation related to any illegal activities conducted on museum property or during museum programs that may take place offsite throughout the state of Florida. An individual search will be conducted if there is reasonable suspicion that a participant has violated Science Center policies, the OSC Behavior Agreement, or the law. The investigation will be reasonable and related to the suspected violation. Further the Science Center will cooperate fully with governmental agencies regarding local or state mandated child protection services, such as court-ordered check-ups with a case worker or guardian ad litem.

All museum areas, equipment, and resources are the property of the Orlando Science Center. The Science Center has recognized the need to respect the rights of individuals while protecting the health, safety, and welfare of all children, families, visitors and Science Center employees. Any individual participating in Summer Camp on Science Center property is subject to search. The search can encompass personal items such as lunch bags, backpacks, or lockers.

I give my permission to Orlando Science Center to use, without limitation or obligation, photographs, film footage, or tape recordings, which may include my child, my family's image, or me for the purpose of promoting the Science Center.

In the event of an emergency, I hereby agree that OSC may initiate the 911 emergency systems, and hereby specifically authorize OSC to do so if it deems such action reasonably necessary. Your signature below allows the Orlando Science Center to transport your child to the appropriate medical facility and begin treatment according to what the responding emergency team deems necessary according to the extent of the injury. I agree to be financially responsible for this child's transport and treatment.

**Refund and Cancellation Policy:**

Refunds will only be issued on cancellation requests made two weeks prior to the start of your camp session. A 20% processing fee is deducted from all refunds.

**Rescheduling Policy:**
